CENSUS HISTORY & CONTEXT



What is a Census?

Carried out by most countries (every 5/10 years) – long history

Collects "population" data – used for statistics purposes only

• Lots of methods (e.g. paper, on-line, both etc...)



Census History

GB & Ireland (1801-1921)

- 1801 England and Wales
- 1841 Ireland (attempts in 1821 and 1831)
- 1841-1911 (decade) 1901/11 http://www.census.nationalarchives.ie/

Northern Ireland

- Northern Ireland: No census in 1921
- Census in 1926, 1937
- an "enumeration" in 1939 rationing & 1948 Health Service
- 1951-2011 (decade) with a 1966 mid-term Census
- 1969 Census Act (Northern Ireland)




2021 Census - volumes

- up to 1 million forms, reminder letters etc...
- 1,900 field staff
- large advertising campaign

- 850k addresses, 750k+ occupied households
- 1,100 communal establishments e.g. Nursing Homes
- 1.9 million people

Proposals Document



Proposals Document - Overview

- Registrar General's proposals for the 2021 Census
- Published on 4 April 2019
- Next Census 21 March 2021 UK-wide
- Census will cover whole population and housing
- Working closely with ONS (White Paper published Dec 18)
- Collaborating with National Records Scotland and Central Statistics Office, Ireland
- Full 'end-to-end' rehearsal in October 2019



Key Strategic Objectives

 To provide high quality, value-for-money, fit-for-purpose statistics that meet user needs, and which are consistent, comparable and accessible across the UK;

 To protect, and be seen to protect, confidential personal census information;

 To deliver a high quality 2021 online census data collection operation;





Key Strategic Objectives

 To maximise overall response rates and minimise differences in response rates in specific areas and among particular population groups;

 To secure public and user confidence in the final results and deliver them in a timely manner; and,

 To encourage wider use and exploration of census results to facilitate greater benefits from census outputs.



Key design features

- Digital-first census 60% target for online responses
- Paper questionnaire also available
- Four page questionnaire no longer than in 2011
- Development of census address register
- Field force of 1,900 to follow-up non-respondees
- Extensive support services provided
- Increased use of administrative data
- Data processing in Northern Ireland





What's the Census for?

Underpins annual population statistics used to allocate public funds

Benefits realisation report for 2011 Census – benefit cost ratio of at least 4:1

Used by private sector to inform investment and better understand demand

Inform the planning and delivery of services

What's the Census for?

Rich source for genealogy and social research

Fundamental to the development of government policy

Used to provide interregional and international comparisons



How did we get to here?

- Programme of consultation, research and testing
- 2015 Topic Consultation
 - 46 responses received assessment published in August 2016
- Public acceptability testing of questions
- 2017 Census Test
- 2017 Address check





Collecting the information

- Challenges to maximising response rate
- Development of census address register
- Enumeration strategy developed
- Digital-first, but paper questionnaire available
- Action plans developed for specific 'hard to reach' groups
- Public contact model developed
 - Initial contact letter and series of reminder letters
 - Field follow-up, with early follow up for some
- Separate arrangements for Communal Establishments



Support Services

- Contact centre
 - Facility for interpretative services
 - Facility for telephone capture
- Assisted digital
- Online help (incl. web chat)
- Online questionnaire available in Irish and Ulster-Scots
- Translation booklets available in 16 languages
- Questionnaire and explanatory material in Braille and large print



Data processing

- Working with ONS to deliver data capture and coding
- NISRA will conduct all subsequent data processing
- Data from administrative sources used to assess and improve data quality
- Plans for an independent Census Coverage Survey
- Developments to the Census Under Enumeration project

Confidentiality, Privacy and Security

- All staff bound by the Census (Confidentiality) (NI) Order 1991 and sign a Census Confidentiality Undertaking
- All census data managed in line with GDPR and the Data Protection Act 2018
- Usage of personal census data will comply fully with the Census Act (NI) 1969 and standards set out in the Code of Practice for Official Statistics
- NISRA will publish/issue a Privacy Notice
- NISRA will carry out a Data Protection Impact Assessment



Legislation

- Primary legislation Census Act (Northern Ireland) 1969
 - Amendment through Census Bill
- Secondary legislation required for 2021 Census
 - Census Order
 - Census Regulations
- In absence of devolved administration the appropriate legislation is expected to be taken forward at Westminster
- Census is fully compliant with the European Convention on Human Rights and the Human Rights Act 1998
- NISRA will carry out an Equality Impact Assessment

Topic inclusion evaluation criteria

- Purpose of User requirement
 - incl. lower geo-levels
 - comparability beyond NI
 - continuity with previous census
- Requirement for multivariate analysis
- Suitability of alternative sources
- Other requirements, incl.
 - data quality
 - public acceptability
 - respondent burden



How did we get to here?

- Programme of consultation, research and testing
- 2015 Topic Consultation
 - Presented NISRA's initial view
 - Sought discussion and development of topics for inclusion
- Range of Topic Expert Panels across all themes
 - These themes were Demography, Migration, Housing, Labour Market, Education, Ethnic Group, Identity Language, Religion, and Health
 - eg Working towards refinements qualifications, health



How did we get to here (cont)?

- Public acceptability testing of questions
- 2017 Census Test (Autumn 2017)
 - 15,000 homes, 2 people / household, 60% of individuals online
 - Order Effect of questions
 - Operation of the Irish / Ulster-Scots filter
- Range of Pop-Up Testing
 - 2017 Balmoral Show language and migration
 - 2019 Balmoral Show Health questions
 - Central Belfast quals, health, sign language, Irish/Ulster-Scots filter
 - Turas, An Droichead Irish / Ulster-Scots filter



Content of questionnaire

- Comparability with previous censuses is important
- Covers household accommodation and individual questions
- Some questions only asked of over 16's
- Majority of 2011 questions remain unchanged
- 4-page questionnaire for all usual residents
- Some details taken for visitors staying on census night



New topics for 2021 Census

Renewable Energy systems

- To inform progress toward achieving government targets
- To establish a detailed benchmark

Sexual Orientation

- To inform policy development
- To enable organisations to meet and monitor their statutory obligations
- Only asked of individuals aged 16 or over
- Includes a 'Prefer not to say' tick-box

UK Armed Forces

- To help to better meet the needs of veterans and their families
- Only asked of previously serving members





New Question – Renewable Energy systems

- Considered the current technologies in use today
- Ability to write in other technologies
- This is energy but the heating question has been amended to include renewables

New Question - Sexual Orientation

- Studied international convention on questions currently in use
- Established question in social surveys
- Question is being made voluntary
- Tested in 2017 test exercise with no issues
- Mitigations
 - 16 and over only
 - Individual form available

Likely Question - UK Armed Forces

- Developed with a number of stakeholders
- Harmonised UK question
- Tested in omnibus surveys
- Security risk raised as issue
 - online first
 - individual questionnaire
- Considering Administrative data alternatives

Questions amended from 2011

- Ethnic Group
 - To include Roma and Filipino
- Ability in Irish and Ulster-Scots
 - To include frequency of use of these languages
- Long-term health conditions
 - To include Autism or Asperger syndrome
- Qualifications
 - Revised after feedback from the 2011 Census
 - To include new question on apprenticeships



Revised ethnic group question

- Revised to reflect current make up based upon admin data sources
- Multiple write-ins as in 2011 to accommodate everyone

- Added frequency of spoken language to question
- Closer to question in Republic of Ireland

Release Schedule


- UK Statistics Authority evaluation feedback Timeliness

- Legal obligation
- Protection from identification
- UK-wide Harmonised approach
- Additional protection over 2011



Cell Key Perturbation


- Statistical technique
- Protection from 'differencing'
- Proportions remain the same
- More timely 2021 Census outputs
- Higher levels of geographies unperturbed





Flexible dissemination tool

- Jointly developing with Central Statistics Office (Ireland)
- Will have user self service facility
 - Allowing customisation of outputs
 - eg Preselection of groups or variables

Output Geography: Making a decision

- Option to retain current geographies or to develop new geographies
- User consideration:
 - Local Government (Boundaries) Act (Northern Ireland) 2008
 - Boundaries Reviews every 8 to 12 years
 - Potential review: 2017 2021
 - Potential new boundaries: 2022 2026
 - Consultation responses
- NISRA consideration:
 - National and international obligations
 - Allocation of public money
 - Utility of census results
- Welcome views on this subject

Census Rehearsal 2019



Census Rehearsal - Overview

- Key milestone in the planning process
- Typically carried out 18-24 months prior to Census Day
- Large-scale rehearsal of processes and systems being developed for the 2021 census
- Rehearsal day Sunday 13 October 2019 same date across UK
- Rehearsal Period Mid-September to Mid November
- Test the major design changes from the last census in 2011 online first approach



Main Aims of the Rehearsal

 To confirm the viability of the proposed 2021 Census field methodologies, data collection services and management arrangements;



 To assess the quality of the collected data arising from the new and innovative methodologies and systems being developed for the 2021 Census; and

• To provide NISRA, its partners and suppliers with exposure to, and experience of, the range of situations likely to be met in the 2021 Census operation so that improvements can be implemented where necessary.

Criteria for choosing the Rehearsal Areas

When choosing our rehearsal areas, we were looking for:


- Mixture of urban and rural areas
- Area with limited broadband coverage/limited mobile coverage
- Area with residents who don't have English as their first language
- Area with a nearby library to test the proposed Assisted Digital service



Locations for the 2019 Rehearsal

- 1. West Fermanagh
- 2. Craigavon
- 3. South & East Belfast

Overall sample size of 19,000 households





West Fermanagh

18 enumeration districts with approx. 4,000 households

Reasons for selection:

- Rural, sparsely populated
- Assess accuracy/coverage of Address Register
- Understand the impact of poorer broadband services on online response
- Test of Field Work App and devices:
 - Area of limited mobile coverage
 - Influence of crossborder mobile coverage from Rol





16 enumeration districts with approx. 7,000 households

Reasons for selection:

- Urban/rural mix with large market town
- Housing tenure mix of rented and owner occupied
- Relatively large migrant population provides test of:
 - Community engagement and communications strategies
 - Language support services

Craigavon





13 enumeration areas with approx. 8,000 households

Reasons for selection:

- Urban, densely populated
- Student population

Two clusters either side of River Lagan in South & East Belfast

South & East Belfast






8 enumeration areas with approx. 5,000 households

Reasons for selection:

- Large student population
- Deprived inner-city
- High number of private renters
- Was difficult to enumerate in 2011 Census

Belfast – Queen's Quarter






5 enumeration districts with approx. 3,000 households

Reasons for selection:

- Provides a reference group
- Non-deprived area
- Easier to enumerate in 2011
